

IWC/60, Santiago, Chile:
Information on visa requirements for entering Chile

Information on visa requirements for participants to IWC/60 travelling on passports issued by IWC member countries are provided in the table attached. This information has kindly been provided by the Government of Chile. Please pay attention to the information provided in the footnotes to the table.

Participants are encouraged to check their visa status and if a visa is needed, to apply for one as early as possible. Visas can be obtained in any Chilean Consulate around the world.

Please note that nationals of some countries are required to pay a reciprocity fee upon arrival at the airport (see table). These fees should be paid before going into the immigration line. Look out for signs showing where to pay.

Participants who will be travelling on passports of countries not listed in the table below must verify their own visa requirements.
