Pre-Meeting on seismic surveys and their potential impacts to cetaceans

At IWC/57 in Ulsan, it was agreed that a two-day meeting would be held immediately prior to the Scientific Committee meeting at IWC/58 to assess the potential for seismic surveys to impact cetaceans.

The agreed Terms of Reference are to:

- (1) review and characterise information on seismic sound sources, attenuation and their effects on cetaceans;
- (2) review case studies where on-going seismic surveys overlap with cetacean distribution in critical habitats and wide-ranging areas (i.e. migratory paths);
- (3) review and evaluate effectiveness of current mitigation and monitoring programmes during planning, operational and close-out phases of seismic surveys;
- (4) discuss potential impacts for cetaceans and recommended/needed changes in mitigation and monitoring during all phases of seismic surveys.

Further details can be found in IWC/57/Rep1 Annex K.

This pre-meeting will be held from Wednesday 24 May to Thursday 25 May 2006 at the St. Kitts Marriott Resort, St. Kitts, West Indies. Registration details will be included as part of the Annual Meeting online registration process and sent to you shortly.

Note that individuals associated with particular draft Agenda Items will only be invited to introduce the specified topic with a short presentation (10-12 minutes with 3-5 minutes for questions). The majority of time for each Agenda Item will be spent reviewing, evaluating and critiquing papers that are submitted for that topic. Discussion of each topic will be most effective and useful with relevant contributions of a) reports prepared by committee members that address a particular topic and/or b) 'for information papers' (i.e. existing reports or publications) that are submitted to the IWC for the Workshop.
